- In 2017 allergies affected as many as 30% of adults and 40% of children in the US.
- ▶ 55% of the US population tested positive for at least one allergen.
- Every 3 minutes, a food or plant allergy reaction sends someone to the ER.
- Once a serious allergic reaction (anaphylaxis) starts, the drug epinephrine is the only effective treatment.
- ▶ Allergies currently rank 5th among other leading chronic diseases in the US, this translates to more than 60 Million Americans being affected by or suffering from allergic disorders.
- There are less than 4,000 certified allergists in the US to test, diagnose, treat and educate allergy sufferers.

ALLERGY TESTING: Our Testing Protocol

Skin Prick Test
We apply a small amount of
allergen (the substance that
might cause an allergic
reaction) to a pricked area of
skin and observe any reaction.



Percutaneous testing (prick or puncture)

CPT Code 95004

Intradermal Test
If the skin prick test shows no reaction, we perform the more sensitive intradermal test, where we inject a small amount of allergen under the skin.



Intracutaneous
testing (intradermal)

CPT Code 95024

We follow AAAI guidelines which state that both skin prick & intradermal tests must be performed on all allergy patients in order to ensure accurate test results.

ALLERGIES: Patient Treatment Plan

Immunotherapy Treatment:

An extract of a small amount of the allergen is injected into the skin of the arm.

An injection may be given once a week (sometimes more often) for up to seven months

Treatment plan will decrease the number of administered to every two weeks.

Eventually, the treatment plan lessens the injections given to every four weeks.





Our Laboratories:

Every one of our laboratories are set up with the mindset of **safety first**.

We provide a refrigerator in each practice to hold testing fluids/allergens.

Only designated personnel are able to access Medical supplies including allergens, needles etc.

Every tested patient is monitored closely after procedures before leaving the office.

Patients diagnosed with severe allergies are prescribed Epi-pens for emergency USe.* (Those patients are educated on how & when to use the Epi-pen correctly).








* EpiPen is an injection containing epinephrine, a chemical that narrows blood vessels and opens airways in the lungs. These effects can reverse severe low blood pressure, wheezing, severe skin itching, hives, and other symptoms of an allergic reaction.
